Sealed bids will be received by the Board of County Road Commissioners of Montcalm County at their offices located at 619 West Main Street, Stanton, MI 48888 until **1:00 PM, TUESDAY, DECEMBER 14, 2021**, for furnishing any part of the seasonal requirements for the following:

CORRUGATED METAL CULVERT WITH RE-ROLLED ENDS

Bidders shall submit a price list for the above materials indicating any discounts based on delivery, FOB, Stanton, Michigan. The bid shall be as on the attached bid sheet. Prices shall remain firm for 90 days from the bid opening date. All material and workmanship are to meet or exceed the current Michigan Department of Transportation Standard Specifications for Construction.

The bidder shall be responsible for CDL compliance for all employees and/or sub-contractors used in fulfilling the delivery of metal structures.

The Board of County Road Commissioners reserves the right to take quotes on 3 x 1 or 2-2/3 x 1/2 corrugated culverts, pipe arches, plate pipe arches and other large culverts on a project-by-project basis.

All bids shall be submitted in a **sealed envelope** marked "CORRUGATED METAL CULVERT" and shall include the name of the bidder. **Faxed or e-mailed bids will not be accepted.**

The Road Commission for Montcalm County reserves the right to reject any or all bids or any portion thereof and to accept the bid that in the opinion of the Board is in the best interest of the Road Commission for Montcalm County.
