Moved by Brundage, seconded by Scott, to approve the agenda as presented. Motion carried.

Moved by Scott, seconded by Brundage, to approve the minutes of the February 5, 2020 meeting as presented. Motion carried.

Moved by Scott, seconded by Brundage to accept and file the bids for limestone grave resurfacing. Roll call: Brundage-yes, Scott-yes and Linton-yes. Motion carried.

Manager's Report

- It's been a busy month since we met last. The Coronavirus issue has been taking a lot of my and Kim's time the last few days. We are doing all we can to assure our employees are protected while here.
- We have decided to start ten hour days beginning Monday to help our employees if they have daycare issues. Starting tomorrow the building will be closed to the public until further notice. Permits are available online and can be sent via email or fax. And payments are accepted online.
- Gravel roads are in better shape today than they were in September.
- Patching county wide is going well. The spring break up hasn't been too bad. We weren't sure how they would fair with all the moisture in the ground.
- Weight restrictions will end tomorrow, March 19th at 6:00 a.m.
- Dale, Pat, Pat and I have met with three companies that will provide site plans and proposals to build a new truck garage in Stanton. This is just a starting point to see what our future needs look like.
- We (EMS and MCRC) are going to be sending out proposals in the near future to prepurchase fuel for a locked in price for the fuel station. With prices this low, it's going to benefit us to lock in a price for 12 months.

Engineer's Report

- A letter will be sent to Michael Giffee on North County Line to remove a gate in the right-of-way.
- 17 of 20 townships have received their road work contracts.
- We are working with the cities and villages on their proposed road work. There is a considerable amount of work they are requesting contracts for.
- We have received the letters from MDOT awarding us the 3 safety projects for 2021.

Moved by Brundage, seconded by Scott, to approve the February 13, 2020 bills totaling \$371,933.67, February 27, 2020 bills totaling \$683,298.80 and March 12, 2020 bills totaling \$257,266.80, Payroll #4 totaling \$104,466.83, Payroll #5 totaling \$106,176.42 and Payroll #6 totaling \$98,330.04. Roll call: Brundage-yes, Scott-yes and Linton-yes. Motion carried.
