The Pledge of Allegiance was said, and a prayer was given by Commissioner Brundage.

Moved by Brundage, seconded by Scott, to approve the agenda as presented. Motion carried.

Moved by Scott, seconded by Brundage, to approve the minutes of the March 18, 2022, meeting as presented. Motion carried.

Joseph Kormos, from Lithtec, was present to talk about a product he is selling that strengthens paved roads. Mark will participate in an online seminar and call him if it is something in which we are interested.

Moved by Scott, seconded by Brundage to enter into closed session at 9:22 a.m. pursuant to the Open Meetings Act 267 of 1975, 15.368, Section (c) for a strategy and negotiation session for the upcoming AFSCME 1071.03 contract. Motion carried.

The board returned to open session at 9:57 a.m.

Manager's Report

- We are behind on grading due to the weather. We need sunny dry weather to help us out with the drying process.
- Local blacktops are in rough shape after the winter. Many townships are looking at overlays or repair of local roads.
- Our federal aid exchange is completed with Kent County Road Commission. We should expect a check in May that will be for the Federal Road job.
- There will be a minimum of twenty-five million dollars available through MDOT for federal aid purchase at \$0.90 on the dollar. We will try and be at the front of the line rather than the end of the line for this option.
- Weight restrictions ended this morning at 6:00 a.m.
- We will be partnering with Kent County Road Commission and Spencer Township on South County Line Road. Our portion will be 15% of the project.
- There are eight county drain crossings that we will pay for and repair this summer with the ARPA funds from the county.
- There is a pre-con meeting for the new building at the end of April. Funding should be in the bank tomorrow morning.
- The May and June chloride schedules are almost ready. We will post them on our website when finished.
- We have our 5-year soil erosion review with EGLE next week.
- Applications are due today for the Sidney Township Truck Driver position. We will review tomorrow and conduct interviews soon.
- We can expect a 10-12% salt price increase for next year. Kent County is working on the bids.

Moved by Scott, seconded by Brundage, to approve the March 24, 2022, bills totaling \$780,234.07, the April 7, 2022, bills totaling \$577,374.41, Payroll #5 totaling \$109,096.78 and Payroll #6 totaling \$114,123.69 as presented. Roll call: Brundage-yes, Scott-yes, and Linton-yes. Motion carried.

There being no further business to come before the board, the meeting adjourned at 10:33 a.m.
