- We are 47% done with the paving projects. We have 67,155 tons scheduled and have placed 35,265 tons. August will be a big month for paving. We will be placing 13165 tons by August 31. We will be 72% done with 18,725 tons to go.
- The Federal Safety project on the north 1.5 miles of CR599 (Federal Road) was proposed to start next week. We haven't heard anything from the contractor. We anticipate that date to be pushed out until September.
- The Local Task Force meeting is tomorrow, August 18.
