The Board of County Road Commissioners of Montcalm County held their regular meeting at its office located in Stanton, Michigan at 9:00 a.m. on April 19, 2023.

Present: Commissioners Dale Linton, Robert Brundage and Michael Scott; also present: Mark Christensen, Managing Director, Pat Denton, Assistant Highway Engineer and Kim Alexander, Finance Director/Clerk. There were also several residents present.

The Pledge of Allegiance and a prayer were given.

Moved by Brundage, seconded by Scott to approve the agenda as amended. Motion carried.

Moved by Scott, seconded by Brundage to approve the minutes of the April 5, 2023, meeting as presented. Motion carried.

Ron Finegood of Stanton was present to inquire about a tree he thinks is in danger of falling onto Stanton Road. Mark explained that we have been cutting dead trees in the right-of-way all winter. This tree is on the list of trees to be cut or trimmed.

The following resolution was offered by Commissioner Brundage and seconded by Commissioner Scott:

WHEREAS the property owner adjacent to the portion of Lincoln Street lying east of Lincoln Street in the plat of Platt's Park Rock Lake, Richland Township, Montcalm County, Michigan is seeking to vacate said portion of Lincoln Street and the same adjacent property owner has requested the Road Commission for Montcalm County to relinquish jurisdiction of that portion of Lincoln Street to Richland Township;

WHEREAS, that portion of Lincoln Street is not used for road purposes and has not and is not maintained as a road by the Road Commission; and

WHEREAS, the Road Commission has determined that it is in the best interest of the public to relinquish jurisdiction over that portion of Lincoln Street to Richland Township;

NOW THEREFORE BE IT RESOLVED that the Board of County Road Commissioners of Montcalm County hereby relinquishes jurisdiction to Richland Township the portion of Lincoln Street described as follows:

A portion of Lincoln Street lying between lots 36-39 and 40-43 of the plat of Platt's Park Rock Lake, except the west 20 feet of said Lincoln Street, Section 29, T12N, R05W, Richland Township, Montcalm County, Michigan.

BE IT FURTHER RESOLVED that a copy of this resolution be published in a newspaper printed and circulated in this county, once each week for three successive weeks, a copy forwarded to the Montcalm County Register of Deeds, the Richland Township Board, and the Michigan Department of Transportation and a copy of same be placed on file at the Road Commission.

BE IT FURTHER RESOLVED that the Road Commission reserves an easement for public utility purposes within the abandoned portion of Lincoln Street.

- We are pulling berms on gravel roads to prepare for township projects. Should finish next week and move on to paved roads.
- The new shop employee is onboard and doing a good job. Michael Moore is now a temporary truck driver for the summer. I'm in the process of contacting summer help applicants and we are scheduling drug tests. Most will start in mid-May.
- The two new Peterbilts are here and in the old truck garage.
- Looking into safer ways to flag. Action Traffic will be here this week to do a demo of an electronic flagger they are selling.
- Fisher Transportation started regraveling local roads on Tuesday. They hope to stay in the area until all contracts are done.
- Pavement Recyclers will be here next week to begin rotomilling for crush and shapes.

- Seven County Council meetings was well attended.
- Thanks to everyone for the support last week. It was a tough week.

Engineering Report

- The Masters Road bridge over Tamarack Creek project is progressing. The deck is scheduled to be poured this week.
- The Dickerson Lake Road bridge over the Flat River is also progressing. The new wood deck is on. The contractor is working on the approaches. Paving is scheduled toward the end of next week.
- Township contracts continue to arrive. This will be our largest paving year to date.
- The rotomill contractor will begin next week. We have 8.5 miles of rotomill at this time.
- The cold mill contractor will begin on May 1 on CR599 (Federal Road).
- The paving contractor is scheduled for the second week of May.
- The pavement marking contractor has begun to paint primary roads east of M-91.
