The Board of County Road Commissioners of Montcalm County held their regular meeting at its office located in Stanton, Michigan at 9:00 a.m. on November 16, 2022.

Present: Commissioners Dale Linton, Robert Brundage and Michael Scott; also present: Mark Christensen, Managing Director, Pat Denton, Assistant Engineer and Kim Alexander, Finance Director-Clerk.

The Pledge of Allegiance and a prayer were given.

Moved by Scott, seconded by Brundage to approve the agenda as amended. Motion carried.

Moved by Brundage, seconded by Scott to approve the minutes of the October 26, 2022, meeting as presented. Motion carried.

Moved by Brundage, seconded by Scott to support the application submission for the Federal Aid Buyout Program Exchange with MDOT for 2024. Roll call: Yes – Brundage, Scott and Linton. Motion carried.

Commissioner Scott offered the following resolution and moved for its adoption:

Moved by Scott, seconded by Brundage, to accept and file the bids for the Morley Rest Area. Motion carried.

Manager's Report

- We are treating roads for the first time this season today. We got through yesterday with no call ins due to the temperature rising.
- About 70 percent of our fleet is ready for winter. The remainder will be done this week.
- Yale Parker will begin Night Patrol on November 27th.
- Construction season is officially over. We will be cutting brush and trees and blading gravels when weather permits.
- We are awarding the 4 western townships applied chloride bid to D & B Brine. The remaining sixteen townships will be done by Michigan Chloride.
- We still aren't sure when or where the December MTA meeting will be held. I will update you once I find out.
- The Wyman Road overlay has been moved to next spring.
- Two internal candidates were interviewed for the Shop Clerk position. A decision will be made by weeks end.

Engineer's Report

- Construction season is over. All projects have been finished.
- We are currently driving the township roads and getting maps and projects ready for township meetings in December.
